HAVERHILL SCHOOL COMMITTEE Regular Meeting of June 10, 2010

Mr. Shaun Toohey, President opened the meeting at 7:10 p.m. Present were: Attorney Paul Magliocchetti; Mrs. Susan Danehy; Mr. Raymond Sierpina; Mr. Scott Wood; Mr. Joseph Bevilacqua; Dr. Raleigh Buchanan, Superintendent of Schools; Dr. Steven O'Brien, Assistant Superintendent of Curriculum; Ms. Kara Kosmes, Assistant Superintendent of Finance. Mayor James Fiorentini, Chairperson was recorded as absent (arrived at 7:15 p.m.).

Mr. Toohey led the Pledge of Allegiance.

Public Comment

Anastasia Dimopoulos indicated expressed there is never any long term planning and recommended selling the old buildings, workers making health care concessions, and the PTO's are making purchases that are not supplied by the district.

Bill McArthur thanked the Superintendent for his efforts with the resources and tools he was supplied to attain his goals. He asked to start to do things differently since funding resources are not available. He questioned Whittier Regional's taking students out of district and to look at their budget. He continued to request the legislators to attend and the Whittier Regional members attend these meetings at least twice annually. He stated each year's budget must be at least a five percent increase yearly.

Moved by Mr. Wood and seconded by Attorney Magliocchetti to suspend the rules for Glen Koocher of MASC to speak on the procedure for Superintendent open interviews.

Mr. Koocher gave the format the open interviews for the Superintendent candidates:

- Open interviews are scheduled for Wednesday, June 18
- Discussion is at 45 minute interval: 7:30, 8:15, and 9:00 p.m.
- Members pose questions, pose follow ups, and probe the candidates themselves
- At end of process which is appropriate, members can discuss candidates prior to taking vote
- Reminded members that this is public and problems can ensue if comments are made and taken out of context and are on the candidates record forever
- Using the ballot method where the Chair calls the roll indicating the name of the candidate and not a Yes/No vote
- Chair will ask for anyone to change a vote and members can change vote for unanimity
- If candidate has a majority a motion is made to begin negotiations with candidate subject to agreement for mutual agreement of employment from beginning to end.

Mr. Koocher stated it is fair for all candidates to be posed a similar interview. He recommended preparing questions ahead of time and follow up not be scripted. Candidates usually have different strengths. Opening statements should be between three to five minutes with closing statements two to three minutes.

It was the consensus of the committee it takes four votes to elect an Interim Superintendent.

Moved by Mr. Wood and seconded by Mr. Toohey to adopt the ballot method and in that method that the Interim Superintendent in order to be appointed must receive four votes from the committee no matter how many members are in attendance.

Attorney Magliocchetti asked for a friendly amendment to include four affirmative votes to be elected.

Mrs. Danehy clarified a ballot vote means they speak the individual's name.

Attorney Magliocchetti removed the friendly amendment.

Dr. Buchanan reviewed the process for the position of Assistant Superintendent of Curriculum and Instruction indicating receiving 27 candidates. Mary Malone has been chosen the selected candidate. She is willing to accept the position if offered. This will give Ms. Malone time to meet with Dr. O'Brien prior to his exit. .Dr. O'Brien is leaving June 18 and critical issues need to be addressed to the state.

Moved by Mr. Wood and seconded by Mr. Toohey to approve the recommendation of Mary Malone as Assistant Superintendent of Curriculum and Instruction.

Attorney Magliocchetti raised concerns as to the open Principal position at Consentino and questioned a contingency plan with so much change going on. Dr. Buchanan stated they have a back-up plan but will violate trust if he discusses it further. The Superintendent assured members that someone will be in her current position within four weeks. Mr. Sierpina expressed concerns with the lack of experience with curriculum and instruction and we have so many vacancies at the executive level we need to get people to lead the district and to build a foundation for our community.

Mr. Wood asked for a friendly amendment to confirm the appointment subject to Ms. Malone to work out favorable contract terms with either Dr. Buchanan or the Interim Superintendent.
