Carol Ireland, HHS, co-advisor for the Violence Intervention Prevention (VIP) Team, with the assistance of two students presented to the committee a video recorded this summer on bullying.

Conduct of Student Athletes

Members discussed the conduct of students at school sponsored events, using different standards for different students, actions of the administration, looking into a policy that would be standardized for said offenses, and the need to look into regulations to see if they are consistent with other policies.

Moved by Mr. Wood and seconded by Mr. Toohey to refer this item to the policy subcommittee. A verbal vote indicated all in favor.

Attorney Magliocchetti

School Committee Conduct

Mr. Wood reported on the policy subcommittee meeting. Different options were discussed for the handbook relative to member conduct and their role during meetings. Once finalized, the policy will be brought forward for approval.

Middle School Band – Introduction of Middle School Band Director & Program Overview

Arthur Bakopolus, newly appointed director, gave a brief synopsis of his background and what his program consists of relative to instrument instruction in the middle schools.

<u>Dress Code – Principals, teachers and students</u>

Attorney Magliocchetti discussed his handout which included conflicting research on the impact on student achievement relative to uniforms and/or dress codes. Members agreed on more uniformity on what students are wearing and suggested referring it to the Superintendent to ask him to make a recommendation back to the committee and be in correlation with the policy and high school student handbook. It was the consensus of members to have a stricter or tighter dress code for all schools.

Athletic Department Budget

Moved by Attorney Magliocchetti and seconded by Mr. Toohey to table this item to the next meeting. A verbal vote indicated all in favor.

Status of Cleanliness of All School Buildings

Mr. Scully reported the schools are much cleaner and is putting a full court press on problem areas and is not letting this issue die. Mr. Sierpina requested of the Superintendent to check on a bathroom in the high school A wing.

STEM – Race to the Top Article/Questions

Mr. Sierpina referenced an article which gave an outline of what the four to five year proposals would be. Mr. Scully stated once the plan is written it will have portions of the STEM plan that will go forward for the next four years. It will be submitted to members once it is submitted to the state. Once things are formulated, they will be brought back to the members.

Nurse Leader Position Status

Mr. Sierpina questioned the status of the Nurse Leader Position. Ms. Kosmes indicated the position has been posted and hopefully within the next two to three weeks they will have a nurse leader in place. It was noted that this position will now be a Supervisor of Health and Nursing with a change in job description duties.

Special Education Update – "Quarterback" vs. Lead Teachers

Mr. Scully stated the increase in demands of sped at the high school. The savings in hearings will more than cover the cost of this person. This is an issue in addition to state reporting that needs to be addressed.

St. James Lease - Status Report

Ms. Kosmes stated they are into the lease until June 3, 2012.

Status of Application for School Building Fix

Ms. Kosmes has submitted the application for six buildings. The request was approved through City Council and the application filed. Upon notification of being selected, this will come back to the school committee for approval and then go to the city council for final approval agreeing to pay the difference 28%.

Staff Visit to South Lawrence East Elementary School – An Overview

Mr. Scully has been sending staff to meet with Mary Toomey in Lawrence whose school has raised scores up tremendously. A gain of the visit was a data wall. All primary schools are mirror imaging this which will drill down to the classroom. Mrs. Malone is now arranging for a meeting at a Lowell middle school.
