## Superintendent's Comments/Reports

Weekly meetings are being held dealing with high school issues or pods and enhancing the course of studies.

Principals are meeting to review school configuration and building usage throughout the city and how to incorporate the all day kindergarten concept without a financial burden to the city. A financial analysis has been done on St. James School and would not realize or capture the reimbursable amount if located to another area. This location is currently working for the school system.

# RTTT Review - Mrs. Malone

Mrs. Malone provided members with a copy of the common core standards. These frameworks have been merged with the Massachusetts standards. They are posted on the website for staff and parents and the process of professional development with the staff will begin on March 4<sup>th</sup>. All curricula will be aligned by end of the school year 2012-2013. Mrs. Malone indicated all states have been augmented with 2.5% in ELA and 4% in Mathematics. The grant writing for the RTTP will begin this summer for years three and four.

## FY12 Budget Update – Ms. Kosmes

Ms. Kosmes presented preliminary numbers which will give them a track from funds from the state and local sources reflecting a deficit of \$185,327 or basically level funding. This does not factor in grants lost through stimulus funds and where we can redeploy funds. Grants are very specific as to what programs they can be used towards. This is strictly a funding update. Mr. Bevilacqua has requested of the state representatives to come forward once they are aware of funding.

## Subcommittee Reports

Mr.Toohey commented on the public forums with issues discussed with Mr. Scully on curriculum and maintenance. Mrs. Danehy asked the public to email their thoughts to Mr. Scully as to what they would like to see the superintendent focus on in year one and the next three years, what do you see as positives and negatives, and to give them an idea where you would like to see where resources should be.

Mr. Bevilacqua indicated he has provided a new committee structure and assignments to members.

# <u>Identification for Kindergarten & First Graders at Bus Stop</u>

Mr. Bevilacqua indicated several bus drivers have informed him of students who do not have identification on them and are unaware of their addresses. He asked Mr. Scully to meet with the appropriate individuals to provide identification for those students. Attorney Magliocchetti referenced the current policy and to bring the bus drivers up to date on said policy.

Moved by Mr. Wood and seconded by Attorney Magliocchetti to appoint Mr. Toohey as the Whittier Regional Committee Representative for the one-year term to end December 31, 2011. A verbal vote indicated all in favor.

#### Scholarships available to Haverhill students

Attorney Magliocchetti stated the Guidance Department has the available information for parents. Mr. Scully reviewed the packet document and is in the process of coordinating the scholarships which are available to students. This list is available on the webpage with a new webpage rolled out in two weeks.

## <u>Curriculum Development</u>

Attorney Magliocchetti referenced the K-12 Curriculum and the Classical Academy at the high school. Mr. Scully stated the K-12 staff will be ready by February 15<sup>th</sup>. Problems are in the Classical Academy with other subjects. They are generally all set to begin in February and are working on staffing and curriculum alignment. Mr. Scully stated they are adding a Pupil Personnel Services Director on the same level as the Special Needs area. They are combining some of the requests into one position. The only cost would be one administrator who will be supervising all pupil services.

## **Building Maintenance Update**

Ms. Kosmes met with Mr. Dill this week to review all work orders. An updated report will be forwarded to members. As of today there are 78 outstanding work orders with 28 being repaired but staying on the work order as a reminder, 12 are roofing issues, 12 work orders for plumbing issues, 7 are waiting for parts or a contractor,10 are ballasts that need to be replaced, 1 being the high school roof which stays on until closed out. Mr. Dill plans to return in February with an update. Attorney Magliocchetti indicated they still don't have a clear idea of the maintenance issues of what is being fixed and what isn't and where our dollars are going. This problem needs to be resolved. Mr. Wood indicated the Superintendent supervises the maintenance department. He asked for the Superintendent to take charge of the situation and department. Mr. Scully stated he has divided services and delegated them under Mrs. Malone and Ms. Kosmes and will make sure he will have the answers for the next meeting.

## MAP Testing – Grade levels, subjects tested, results, Accountability

# **Greenleaf Computer Lab**

Mr. Sierpina indicated MAP testing is for students in Grades 2 – 5 three times per year. Mrs. Malone stated these diagnostic tests depend on the computers available. Greenleaf students use the Hunking computer lab. Students at Walnut Square go to J. G. Whittier and Crowell go to Golden Hill. He indicated some buildings have outdated equipment and asked if Greenleaf can acquire computers so they don't have to travel. Mr. Scully stated they are trying to fast track this get a lab or mini lab at these schools and be fiscally responsible. A discussion was held as to students doing their work from their home computer.

## Entrances/Exits to our "newer schools"

Mr. Sierpina expressed concern as to the one lane access to the Golden Hill School and questioned a second egress to the building. Mr. Scully was directed to contact the Mayor and Public Works to address this problem.

#### School Nurse Leader Update

Mr. Sierpina questioned if a new organization for the nurses has been implemented. Mr. Scully stated they are currently working on this with adequate services until issues are resolved.

## Status of Custodial Reorganization

Mr. Sierpina questioned the custodial reorganization. Mr. Scully stated it is going well and there is a need for someone to coordinate custodial activities, to increase the evaluation and hold people accountable.
