Kelly Valaskatgis, President, Haverhill Parents Shaping Schools, urged members to replace the aging middle school structures referencing the safety concerns and wellbeing of parents, children, and staff. Mr. Scully reviewed the issues at Hunking including the findings of the industrial consultant. Once determined to build a new school a statement of interest needs to be filed relatively soon. The Superintendent assured parents this is his main concern and is checking it daily. This item will be put on the next agenda.

The Superintendent addressed members on cutting the budget user fees and to take into consideration his instruction to follow their votes and asked them to take into consideration all the facts and his input. He does not want to come in with a deficit.

Donations – Vote to Receive

Moved by Mr. Bevilacqua and seconded by Attorney Magliocchetti to accept the \$25,000 endowment anonymous donation which is a condition of said gift which will benefit Haverhill athletics. A verbal vote indicated all in favor.

Technology Update

The City Council has authorized \$803,000 and up to \$1 million in available funds to redo the technology program at the high school.

High School - Open House Update - November 14, 15, 16, 2011

A promotional brochure is available describing the program for students. Placement exams for all eighth grade students will be held on November 7th in middle and parochial schools. Tours are available with a theater presentation and a performance by the band.

Personnel Actions

The Superintendent referenced the packet. All supervisor positions are filled with two teaching still available. The recently hired technology person has resigned for a higher paying position.

Attorney Magliocchetti thanked all who attended the meetings. This completes a phase of the Strategic Plan. The public is invited on November 9th and 30th for final input on the plan which is on track for its deadline at the end of the year.

Status of Green Schools funding

The Mayor has asked for an extension of 60 days from the state and not go ahead with the program at Hunking. The Mayor stated they received an offer of \$200,000 for one of the schools for sale and are trying to negotiate the P & S. No offer was made for the Cogswell School and the Winter Street offer was per unit. Attorney Magliocchetti recommended using an auction company to auction the buildings. The Mayor wants to be assured they won't need Cogswell for other purposes before going forward with a sale.
