

# Haverhill School Committee Regular Meeting of October 25, 2012

Mayor James Fiorentini, Chairperson called the regular meeting of the Haverhill School Committee to order at 7:03 p.m. Present were: Mr. Raymond Sierpina; Mr. Shaun Toohey; Mr. Scott Wood; Mr. Joseph Bevilacqua; Mrs. Susan Danehy, President; Ms. Kara Kosmes, Assistant Superintendent for Finance & Operations; Dr. Mary Malone, Assistant Superintendent of Schools and Mr. James Scully, Superintendent of Schools. Attorney Paul Magliocchetti, Vice President arrived at 7:05 p.m.

The Pledge of Allegiance was recited.

# Presentations.

Mr. Bevilacqua introduced Mr. Peter Carbone, representing Kiwanis and Mr. Frank Novak, representing Rotary who presented at check to the Superintendent James Scully for \$8,700 for technology that will be used towards the purchase of electronic textbooks.

The Superintendent announced that a recent Walnut Square alumni event a donation of I pads was made for students at that school.

Mr. David Mancuso, Regional Vice President of External Affairs from AT&T addressed the committee and noted that through the efforts of Bob LaRochelle his company became aware of some of the initiatives that were being implemented in the Haverhill Public Schools. He presented to the Superintendent a check in the amount of \$10,000 that will support the program, which is outlined below.

The funding will assist with a summer enrichment program targeting eighth grade students to strengthen their social emotional relationship while providing an academically rigorous summer program focused on English Language Arts and Mathematics. The strength of the summer component is the combination of meeting social emotional and academic needs of the students as well as targeting student weaknesses in the two content areas. The summer program allows the students additional adult attention that they need to stay invested in themselves and their future. Furthermore, the summer enrichment will support the transition to high school by allowing the students access to their new environment with a trusted adult and smaller group of students. There will also be limited disruptions while learning with an added benefit of a ½ high school credit for attending. For students who generally work to catch up to their peers, this will be a great start to their high school career. We are also looking as part of this program collaboration with Northern Essex Community College in their sophomore year.

Access to skilled workers is increasingly vital to the Massachusetts and national economies. The contribution to Haverhill High is in recognition of an exemplary program that will help more students graduate from high school ready for careers and college. This contribution is part of AT&T Aspire, one of the most significant U.S. Corporate education initiatives with more than \$100 million invested since 2008 to tackle the issues that face students at risk of dropping out or graduating from high school unprepared for the academic rigors of college.

#### Communications and Reports.

Haley Peabody, Student Advisory Council Representative announced the following events at Haverhill High School:

Spirit Week begins next week with the November 1- Bonfire followed the next evening by the November 2- Homecoming Football Game vs. Lawrence at Trinity Stadium. Mr. Scully extended an invitation to the school committee to attend the bonfire and relayed that it would be a spectacular event.



# Superintendent's Comments/Reports.

Superintendent Scully relayed that Assistant Superintendent Mary Malone was hosting a program on Comcast Channel 99 entitled "Parent & School Connections" which would be a good resource for information for parents. This program will be replayed on that channel.

Mr. Scully introduced Technology Department staff members, Tim DiFalco; Doug Russell; Brian Nangel who were present to discuss the implementation of the ITunes University in the Haverhill Public Schools.

Brian Nangel noted that this was a free service that many large universities utilized to provide digital content. He further stated that it was a free service provided by Apple to educational institutions that allowed them to expose others to their digital library, which might include tutorials and online courses. The Haverhill Public Schools recently began adding online course material to ITunes University. This made it accessible to anyone in the public arena who had an apple device to view our course material.

# School Committee Communications.

The school committee selected Vice President Paul Magliocchetti to represent them at the Annual MASS/MASC Conference on November 9, 2012 in Hyannis, Massachusetts. Attorney Magliocchetti indicated he would meet with the superintendent and assistant superintendents prior to the conference to review the resolutions and then notify the members individually of the determination.

Mr. Bevilacqua suggested a Recognition Program for Haverhill High School Graduates. He acknowledged Tom Bergeron and his career achievements. He proposed a "Tom Bergeron Day" in Haverhill at Haverhill High School. He noted that an Emmy award was a significant career achievement. Mr. Bevilacqua recommended a kickoff for the recognition event followed by a fundraising dinner that evening honoring Tom Bergeron; this would be the First Annual Dinner.

The committee unanimously endorsed this event.

Mr. Bevilacqua reported on a very successful "Go Public" Event held on October 18, 2012 at HHS. He commented that there was an amazing turnout and that it showcased the opportunities in attending a public college. The event was hosted by Representative Brian Dempsey along with the Presidents of University of Massachusetts – Lowell (Marty Meehan) and Northern Essex Community College (Lane Glenn) with the focus of the affordability of a public institution. Mr. Bevilacqua related that students have already earned college credits while attending high school, which will make college less expensive.

Mr. Sierpina acknowledged the receipt of information on the Duties of Curriculum Supervisors along with the rubric used for their evaluation. It was noted that the curriculum supervisors would along with principals be held accountable for MCAS results.

Mr. Scully stated that the roles had been amplified the past two years and their responsibilities increased to grades K-12.

Dr. Malone commented that the supervisors divided their responsibilities between evaluation, classroom instruction and modeling.

In reference to the maintenance projects, Mr. Sierpina was encouraged with cost savings. Mr. Scully noted that he was impressed with the effort.
