

# HAVERHILL SCHOOL COMMITTEE MEETING Thursday, December 12, 2013 - 7:00 P.M.

# This meeting was recorded.

Mayor James J. Fiorentini opened the meeting at 7:04 p.m. Present were: Mr. Joseph Bevilacqua, Attorney Magliocchetti, Mr. Scott Wood, Mr. Raymond Sierpina, Mr. James F. Scully, Superintendent of Schools, and Dr. Mary Malone, Assistant Superintendent. Mr. Shaun Toohey (arrived at 7:30 p.m.) and Mrs. Susan Danehy (arrived at 7:09 p.m.) were recorded as absent.

Mayor Fiorentini moved up Item 3B, Commissioner of Education Mitchel Chester.

# Commissioner of Education Mitchell Chester regarding PARCC

Commissioner Chester recognized Superintendent Scully for his programs, the work the faculty is doing, and where we are headed with our curriculum frameworks. He discussed the newly adopted standards or curriculum frameworks and what it means to be literate in English, Math and Science. He explained the new pilot program of testing which they will reevaluate after two years of field testing to see if they prefer it over MCAS. The tests are designed to make sure the students graduate from school and are ready for success after high school to pursue a higher education. It will make sure students are on track for employment or higher education. He expressed how he is impressed with our schools and the high school program.

Emma Yates informed members of the high school play "The Ghost of Christmas Past", the coffee house held last week and of winter sports beginning.

## Hillie Fuel Check Presentation by John Maddox, M.D. and Thomas O'Brien

Dr. Maddox and Mr. O'Brien discussed the program which encouraged physical activity. Four teams competed that were comprised of two high school students and four staff members. The program was fully funded through a grant from a foundation that puts an emphasis on health and physical well-being. St. James placed first receiving a \$1,000 prize with Golden Hill placing second receiving a \$500 prize. Haverhill High and Consentino came in third and fourth respectively. Wrist bands provided by Nike were worn to track daily exercise. Expansion of the program is being discussed. A check was presented to St. James Principal DePaolo.

Mr. Scully recognized High School Principal Bernard Nangle for his service these past seven years. A portrait of the Golden Gates at the high school was presented to him in recognition of his service to the students. Mr. Scully announced he has appointed Beth Kitsos as Acting Principal

Presentation and Acceptance of the Monthly Financial Report (ending November 30, 2013)

Mr. Scully reviewed the monthly financial report provided by Mr. O'Connor. He explained the impact from the previous year's deficit and requested actions taken to ensure the budget remains balanced. Line items discussed were transportation increases, special education, and the substitute program. He discussed alternatives of layoffs if these transfers were not approved.

Moved by Mr. Wood and seconded by Mr. Bevilacqua to approve the additional City Council appropriation in the amount of \$339,000 which includes additional School Medicaid (\$89,000) and Chapter 70 (\$270,000). A roll call vote was held with the following results:
