Update on Whittier VoTech – Haverhill students for next year – any other updates

Dr. Malone reviewed the hand out citing 309 eighth grade students have applied to Whittier VoTech. Of the 49% of students applying, 210 have been accepted resulting in an overall 68% acceptance rate. Discussion was held as to the criteria for acceptance and how to address the issues resulting in a student not being accepted into their program and to put a plan into place to address the issues.

Moved by Mr. Wood and seconded by Mr. Bevilacqua to request from the Principal at Whittier Middle School a report relative to her feedback as to why students are not getting accepted and the issues as to how is she addressing them.

The Superintendent will acquire the latest information from Whittier VoTech before speaking with the Principal.
