Mayor James Fiorentini called the meeting to order at 8:30 a.m.:



1. Approval of Meeting Minutes from October 14, 2014 SBC Meeting:

MOTION: made by J. Goldfield, seconded by R. Scatamacchia, and approved unanimously, to approve the October 14, 2014 SBC meeting minutes with revisions.

2. Construction Documents Update

JCJ Architecture explained that the work on Construction Documents continues, adding that there is a Conservation Commission meeting on Thursda, December 4, 2014 at which the team will present the Caleb Dustin Hunking School project. The 60% Construction Document package will be ready for estimators on December 13, 2014. R. Scatamacchia asked if the project team expects any pushback from the Conservation Commission, JCJ noted that the Conservation Commission has been part of design discussions since the beginning of the project, and therefore no push back is anticipated. An information meeting was held with abutters last week. The Superintendent noted that the feedback from the community was very positive, adding that some members of the community stressed the importance of school security, while others noted concern about site lighting flooding their properties with light. There were also concerns voiced about drainage between Revere Street and the new site access drive. After researching the area where flooding is occurring, the City determined that flooding is occurring on private property. The Superintendent noted that it is possible that the drains are not always cleaned out, resulting in drainage issues at this location. O. Pacheco will bring this up to the DPW who may be able to assist.

3. MSBA

a. <u>Design Development Review Comments</u>

The Design Development submission to the MSBA was approved at the October 14th meeting, submitted to the MSBA on October 15th, and the City has just recieved comments on the package from the MSBA. A draft response from JCJ is currently in for review with JLA.

Transition Meeting

Last week, the MSBA held a Transition Meeting to discuss the next phases of the project. The meeting was attended by representatives from the School Department, City of Haverhill, JCJ Architects, and Joslin, Lesser + Associates.

Project Funding Agreement

The Mayor has signed the Project Funding Agreement and the document has been sent to the MSBA. This will trigger the beginning of reimbursement from MSBA.

4. SBC Motions / Votes

JCJ Architecture Contract Amendment #8: Members of the committee noted that Amendment #8 is Identified as #7 on the amendment itself. Joslin Lesser will revise.



MOTION: J. Goldfield moved, seconded by R. Scatamacchia, to approve JCJ Architecture Amendment #8 for cost Phase II Environmental Consulting – Test Pits & Borings.

Discussion: J. Goldfield noted that this soils testing is an important issue for the community, more research at this point is beneficial to project.

The Committee voted unanimously to authorize JCJ Architecture Amendment #8 for Phase II Environmental Consulting – Test Pits & Borings.

5. <u>Invoice Approval-</u>

- S. Danehy asked whether these invoices are all accounted for in the budget. Joslin Lesser confirmed that all invoices have been accounted for in the budget.
- J. Goldfield asked whether invoices should be voted on individually. The SBC agreed.

MOTION: S. Danehy moved, seconded by R. Scatamacchia, to approve the following payment to Joslin Lesser:

The Committee voted unanimously to authorize payment of Invoice #19 for OPM Construction Documents Services in the amount of \$30,500.00 to Joslin Lesser + Associates.

MOTION: O. Pacheco moved, seconded by J. Goldfield, to approve the following payment to JCJ Architecture:

■ JCJ Architecture Invoice #5 for A/E – Designer Services for Design Development, performed in October 2014 - \$50,000.00, and A/E – Designer Services for Construction Documents performed in October 2014 - \$214,500.00, for a total of \$264,500.00.

The Committee voted unanimously to authorize payment of Invoice #5 for A/E – Designer Services for Design Development, and A/E – Designer Services for Construction Documents, in the amount of \$264,500.00 to JCJ Architecture.

MOTION: J. Goldfield moved, seconded by S. Danehy, to approve the following payment to Shawmut Design and Construction:

 Shawmut Design and Construction Invoice #5 for CM Preconstruction Services performed in October 2014 - \$15,000.00

The Committee voted unanimously to authorize payment of Invoice #5 for CM Preconstruction Services in the amount of \$15,000.00 to Shawmut Design and Construction.

J. Scully noted that when second site egress for buses was initially discussed, it was determined that a light would be needed at the location of the exit. After driving by recently, the Superintendent noted that he saw that there is currently a street pole at the location in question, but added that it may need to be adjusted to face the access drive as it is currently facing the fire station. The project team will explore this option further to see if it is a viable solution.



6. Public Comment

C. LePage asked if a memo summarizing the potential of utilizing geothermal on-site is available. Joslin Lesser distributed the memo as a handout.

C. LePage asked what security technology will be used in the school. The Superintendent noted that there is a meeting planned to discuss that, adding that security in the new school will be of the utmost importance. The Mayor noted that he was also concerned about the security in the new building.

7. Other Business

- O. Pacheco requested a copy of the LEED registration for the project.
- M. Peugh requested a copy of the MSBA DD Review comments and the team's response letter.
