- Administration is pleased with the accounting firm that has been consulting with the district (Question: Mayor & Response: Mr. Scully)
- The FY15 budget is a baseline for future budgets totally accurate all accounting/budget issues have been addressed (Question: Mr. Bevilacqua & Response: Mr. O'Connor)
- Mr. O'Connor can continue to be employed as the part-time business manager there are no issues with his retirement (Question: Mayor & Response: Mr. O'Connor)
- Health care numbers should be verified with Mr. Benevento (Mayor)
- In-house plumber, carpenter and tradesmen have provided a more economical way to address plumbing issues within the schools and city (Mr. Scully)
- Transportation costs have increased and the district has looked at staggering busses to reduce costs district (Question: Mayor & Response: Mr. Scully)
- All resources are being focused on student learning including lowering class sizes (Mr. Scully)
- There has not been proven research to indicate that lower class size impacts student achievement (Mayor)

- Develop a list of priority items if additional funding becomes available (Mr. Bevilacqua)
- Relationships with colleges has allowed HHS students to enter college with college credits reducing the cost of their college education (Attorney Magliocchetti)
