Lisa Begley, HHS Health Teacher, requested members to read and sign an initiative petition to the Commonwealth. In summary, the proposed amendment would establish an additional 4% state income tax on that portion of annual taxable income in excess of \$1 million. Revenues from this would be used, subject to the appropriation by the state legislature, only for public education, public colleges and universities, the repair and maintenance of roads, bridges and public transportation. This would apply to tax years beginning on or after January 2019.

Status on Statewide Testing
