#### Subcommittee Reports

*Mr.* Wood stated Mr. Sullivan has screened the twelve candidates' applications for Business Manager. Of the twelve, five were selected and interviewed today by the interviewing team comprised of himself, Vice President Ryan-Ciardiello, Superintendent, Scully, Assistant Superintendent Kukenberger, Mr. Sullivan, Mr. Tim Rooney, and from Hunking, Mr. Fulgoni. Of the five candidates, they did not have a candidate to bring back to the committee. He indicated there was a posting error in the salary. He asked that this position be reposted with a salary range of \$115,000-\$125,000 to be negotiated. The interviewing committee agreed this will draw additional qualified candidates, whereas the original posting was for \$80,000-\$99,000. The consensus of the committee was to repost the position.

*Mrs.* Danehy stated the wellness subcommittee is conducting evaluations of all middle school programs (PE, recess time, lunch programs). Nettle School was evaluated on Wednesday with Hunking on June  $3^{rd}$  at 10:00 a.m. and Whittier at noon with Consentino at noon on June  $10^{th}$ . Members are welcome to attend.
