# Silver Hill Horace Mann Charter School Update – Mr. Gene Zylkuski, Chairperson of the SHHMCS Board of Trustees

Mr. Zylkuski offered the quarterly update to members and reviewed the Memorandum of Understanding between the Silver Hill Horace Mann Charter School through its Board of Trustees and the Haverhill School District, by the School Committee of the City of Haverhill. He outlined the charter renewal five conditions. They included: meeting minutes, board training, board self-review and evaluation of members, modifications to the educational model of the accelerated school's program, implement and deliver that new educational model, request a charter amendment and implement and deliver the new educational program. Documents have been submitted to the state, approved by the Board and the HEA pending School Committee signatures for the document amendment approval.

Members requested information on the model they use to have parents engaged in district schools. They asked for the top three things they are doing different as to learning that the other schools are not doing. Mr. Zylkuski will forward the requested information to members.
