

Haverhill School Committee Meeting Thursday, May 22, 2014 - 7:00 P.M.

Mayor James J. Special Education Department Organization 2014-2015

Mr. Scully read and circulated a letter he received as a result of a coordinated review in March, 2013 which included the realignment of the SPED Management in the District. He presented and reviewed a new Organization Chart for approval. This breaks up the quadrants into five sectors which should better address students' needs and those with problematic issues. This will create a savings over the next several years. This will do away with most of the outside evaluations which will now be done by certified staff members. Without this realignment, they will not receive support of DOE.

Moved by Mr. Bevilacqua and seconded by Mr. Toohey to approve the proposed Organizational Chart for Special Education which will bring us into compliance with the necessary state and federal regulations.

Mr. Wood asked for a friendly amendment that the SPED Supervisors are not to be put in the administrators' union and the salaries are to be set by the School Committee in conjunction with the Superintendent. Mr. Bevilacqua accepted the friendly amendment.

FY15 Budget

Mr. Scully presented the Draft Budget for 2014-2015 which shows an increase of 2.7percent from the previous fiscal year. He read the following letter:

May 21, 2014

Dear Members of the Haverhill School Committee:

The preliminary FY 15 budget, which totals, \$93,200,200 represents a dollar increase of \$2,446,044 and a net overall increase of 2.7 percent from FY14. The budget has been prepared using the House Chapter 70 allocation of \$45,091,781 along with an estimated Net School Spending figure of \$83,825,977 as was advised by the DESE.

For the past three years, the School Department has been able to **maintain** services and **gradually** expand programs as funds have allowed. Most notable has been the reduction of class sizes throughout the district and the implementation of the All Day Kindergarten program. The FY15 increase in Chapter 70 funds will allow the district to continue to prioritize both of these initiatives with no reductions in instructional staff or instructional materials.

Funds have been allocated in this budget with the primary focus on increasing student achievement and the improvement of MCAS scores. School budgets include funding for academic coaches along with curriculum materials as needed for specific content areas.

Enrollment in the district has been steadily increasing over the past four years, but most notably at Haverhill High School. This is likely a result of additional program offerings coupled with the expansion of the academy programs from two areas to five (Classical, freshman, Arts and Humanities, STEM and EBIT). The School to Career program will also be enhanced in FY15.

Funding for the Athletic budget has not been increased. The FY15 budget is still not able to fund a Crew Program which is in great demand, but it is hoped that future funding can be identified so that Haverhill's athletic program offerings can be further expanded.

Please be aware that these numbers will change between now and June 30th. This budget document will be updated accordingly at that time for your final approval.
