Courts – All courts are closed. Housing Court eviction cases are on hold until April 27th and district court proceedings are on hold until May 1st. Mediation may happen over the phone. Families who have an upcoming court date are asked to contact the court house. Eviction execution dates already delivered to tenants will remain in effect.

National Grid- Is temporarily suspending collections-related activities, including service disconnections, to lessen any financial hardship the COVID-19 pandemic may cause customers. These policies are effective immediately and will be in place through the end of April. Please note that regular billing will continue for all customers. For those with federal student loans, it was announced that you can suspend payments for at least two months (without incurring interest or penalties) with very minimal effort. You just contact the loan service online or via phone to enroll. Even if your loan repayment is delinquent, you will still get suspended payments. The federal government has also announced that it will be waiving interest specifically for federally-held student loans during this time. Mortgage payments:

<u>U.S. Orders Up To A Yearlong Break On Mortgage Payments</u> - Homeowners who have lost income or their jobs because of the <u>coronavirus outbreak</u> are getting some relief. Depending on their situation, they should be eligible to have their mortgage payments reduced or suspended for up to 12 months. Homeowners can't just stop paying their mortgage. They need to contact their servicer — that is the lender that they send the check to every month.

Tax Information

- The IRS has moved the national income tax filing day to July 15, three months after the normal deadline for Americans to send in their federal returns due to the COVID-19 emergency.
- > The IRS urges taxpayers who are due a refund to file as soon as possible. Most tax refunds are still being issued within 21 days.
- As of 3/24, neither Massachusetts nor New Hampshire had extended their state tax deadlines.

Internet Accessibility Resources
