Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means." This meeting will be available via live streaming over HCTV and WHAV. The full meeting recording will be posted on the HCTV website.

Public Comment.

- Mrs. Maureen Zuber, 84 Agawam Avenue, Haverhill, MA thanked the School Committee ESP Negotiating Committee (Attorney Magliocchetti, Mrs. Sapienza Donais and former member Attorney Rosa) for productive negotiations.
- Mr. Anthony Parolisi, 169 Summer Street, Haverhill MA appreciated the Committee's acknowledgement of the ESP workforce (specifically Attorneys Rosa and Magliocchetti along with Mrs. Sapienza Donais) resulting in a positive proposed contract.

Student Advisory Council - Ms. Gabriela Vargas.

Ms. Vargas related the following HHS activities:

- Welcomed everyone back from Spring Recess;
- Spirit Week is underway with tomorrow being Color Wars Day: Freshmen (White), Sophomores (Blue), Juniors (Black), and Seniors (Red);
- Spring Sports are underway and had a successful start;
- Seniors who did not receive Senior Signs or AP Scholar Signs should notify the high school;
- Student Government/Council elections will be held on May 7, 2021;
- Sign up for next courses is underway;
- AP testing will be occurring shortly;
- Hillie Nation is in the home stretch;

Superintendent Comments/Reports.

Dr. Marotta announced that all students had returned to in-person learning.

Superintendent Marotta announced the appointment of the following principals to fill vacancies within the district:

- Mr. James Brennan, Principal of Pentucket Lake School;
- Dr. Richard Poor, Principal of Consentino School.

Superintendent Comments/Reports ~ COVID Update.

Dr. Marotta along with Dr. Maddox (School Physician) and Ms. Vozeolas (Director of Health and Nursing) provided a report on Reopening Schools during Pandemic 4.29 SC PP final.pdf.

Attorney Magliocchetti asked about the shields in the Council Chambers and its benefits.

Dr. Maddox responded that very little COVID is transmitted through the air but the shields were for peace of mind.

Attorney Magliocchetti asked if the School Committee should be part of pool testing.

Dr. Maddox stated that vaccination was a key component and a game changer and pool testing was more prevaccination.

Attorney Magliocchetti recommended removing the shields.

Mr. Wood concurred with Attorney Magliocchetti and related that the shields were presenting a mixed message.

Superintendent Marotta introduced Mr. Burns and Ms. Dion to discuss senior activities.

Principal Burns reported the following activities at Haverhill Stadium:

- Night of Stars on June 2, 2021.

Additionally, Mr. Burns commented that activities that would be brought back to return HHS to a state of normalcy such as outdoor events: Senior Chapel (back field), Mini-bonfire, Movie Night, Food Trucks, Drama Club Presentation along with Future Educators Signing Event.

Mr. Russell, Director of Technology presented an update on the cyberattack that hit the district in the early morning hours of April 7, 2021, and along with the several investigative agencies involved in the investigation. He also elaborated on the restoration efforts including the restoration of basis services and then the redesigning of the system. He commended his staff for their swift and tireless efforts and actions.

Mayor Fiorentini asked if it was possible to create a separate system for the school department. He also related that MIT had been engaged to conduct a security audit.

Mr. Russell related that it would be better to move systems to the cloud.

Attorney Magliocchetti thanked Mr. Russell and his team.

Mayor Fiorentini recommended children ages 6-16 get the vaccine. He announced a Vaccination Community Event that will be held at the Amvets, Primrose Street.

School Committee Reports/Communications. ~ Ms. Sullivan: Budget Development & Goals.

Ms. Sullivan asked for an update on budget development and goals.

Assistant Superintendent Pfifferling offered an update on FY21 Budget and FY 22 Projected Funding which included <u>Budget Planning 04.29.21.pdf</u>:

- FY21 Funding Recap
- FY22 Projected Funding
- FY22 Preliminary Starting Point/Level Service
- Community Budget Survey: 1,341 Responses
- Community Investment Priorities?
- Leadership Budget Priorities
- FY22 Planning

Mayor Fiorentini was concerned with the salary increases contained in the FY22 budget and the ESSER funds.

Dr. Marotta commented that discussions with state officials had been held to determine future SOA funding in the next several years to see if this could offset additional staffing that would be needed to remediate student learning loss.

Mr. Wood identified the set costs in the budget and noted that without ESSER I & II, the budget would be in a deficit.

Ms. Sullivan commented that the Committee needed to present a recovery/remediation plan in response to the pandemic. She emphasized that learning loss was a key mission of the budget planning.

Mrs. Sapienza Donais asked if there would be summer school programming. Superintendent Marotta responded that there would be a robust summer school. She would have a report presented at the next meeting.

Attorney Rosa requested more detail on the starting point/level service budget, specifically regarding transportation.

Assistant Superintendent Pfifferling explained it was a reimbursement to local funds from ESSER and the annual percentage increase in special education tuition. Dr. Marotta elaborated that the State allowed for an annual increase of 3%; it was not a reflection of additional students.

Dr. Marotta provided information on the Community Budget Survey Responses (1,341) along with a review of FY22 Planning (referencing the PowerPoint presentation slides).

In response to Ms. Sullivan's questions on summer school programming and the inclusion of the Arts and Music as motivation for participation. Dr. Marotta commented that a full day program was being offered for students which would include afternoon sessions through a partnership with the YMCA and the Discovery Club.

Mayor Fiorentini asked about drop-out prevention efforts. Superintendent Marotta replied that mandatory summer school would be designated for eighth and ninth graders who have failed one or more courses; these classes would be held at HHS.

The Mayor asked about additional vocational offerings for students. The Superintendent noted that more details would be forthcoming in future budget discussions.

At the request of Superintendent Marotta, Assistant Superintendent Pfifferling provided an updated budget timeline which included:
