The City received twelve (12) RFS submission responses by Wednesday's deadline from firms interested in serving as the Owner's Project Manager for the Consentino Middle School Project. A total of 36 firms requested the RFS document, and 15 attended the walk-through on August 5th.

The Selection Committee must now follow the OPM selection process outlined on pages 5 and 6 of the RFS document. The first step is for the Committee members to individually review, evaluate and score each submission based on the eleven (11) Evaluation Criteria listed on pages 3 and 4.

Please use the attached ratings sheet to record your evaluation and scoring of each response/firm. The maximum number of points that can be assigned to each firm during this stage is 90, with the final 10 points reserved for the interviews of the short-listed firms. You will see that most if not all of the firms are well qualified to act as OPM for the project, likely warranting high scores. Therefore, it is suggested that you use pencil for an initial pass at scoring, jot down some notes on each of the firms as you work through the responses, and then review/revise your scoring after you have read, considered, and compared all of them.

Based on the process schedule that has been established by the CSBC, and approved by the MSBA, the OPM Selection Committee must complete its evaluation and scoring work, including interviewing at least three short-listed firms, and convey its recommendations back to the full CSBC in approximately one month's time (i.e., no later than Friday, 9/18). Needless to say, there is a lot that needs to be accomplished, and we will need everyone's commitment and cooperation in order to meet this relatively tight schedule.

Please complete your individual evaluations and scoring of the twelve responses/firms over the course of the next ten days or so, and send a copy of your ratings sheet back to me be email (The CSBC will be required to provide the MSBA with a compilation showing each OPM Selection Committee member's total score for each of the responses/firms). Please also be prepared to meet remotely in the afternoon of either 9/1, 9/2, or 9/3 to discuss the scoring results and determine the short list of 3-5 firms to invite for remote interviews during the 2nd and 3rd week of September (we will be contacting you soon to confirm your availability). Please let me know if you have any questions at this point in the process. Thank you.
