Dr. Margaret Marotta, Superintendent of Schools and Mr. Michael Pfifferling, Assistant Superintendent were present in person.

Mayor Fiorentini, Chairperson read an act relative to extending certain COVID-19 measures adopted during the state of emergency was signed by Governor Baker and allows for remote meetings and hearings by public bodies through April 1, 2022. This meeting will be available via live streaming over HCTV and WHAV. The full meeting recording will be posted on the HCTV website.

The Pledge of Allegiance was recited.

Communications/Reports.

Student Advisory Council Report ~ Ms. Hailey Prunier.

Ms. Prunier provided the following report on HHS activities:

Public Comment (In-person & Remote).

Mr. Peter Yannakoreaus, 185 Millvale Road, Haverhill, MA questioned the committee the reasoning behind not answering his question on religious ideology.

Representative DiZoglio's Aide presented a certificate to Sylvia Pastrana Scott and it was received on Sylvia's behalf by Cara LaBelle.

Ms. Lynette Hickey, 74 Wheeler Avenue, Haverhill, MA spoke in favor of mask choice regardless of vaccination status.

Ms. Kara Sotirakopoulos, requested that the committee "stop the madness" and focus on addressing the results of mitigation methods such as learning loss and depression in children. She stated that forced

masking of children will never happen again in this country.

Mr. Travis Ducharme, Hunking School Special Education Teacher addressed the false report from the CDC study which cited that masking prevented disease transmission. He mentioned multiple sources of data which indicates the harm that masks have caused for children. Mr. Ducharme gave statistics and focus on the holistic approach to health for youth.

Mr. Adam Rodis, 1 Brandon Road, Haverhill, MA, commented that DESE still left the option for masks. He related that the school committee (community servants) was hampered by the state.

Ms. Alexandra Phipps, Rosemont Street, Haverhill, MA spoke as a student about fear associated with mask wearing and teacher comments "that she is killing people" and thanked the committee for the discussion and consider the science and well-being of students.

Mr. Barry Davis, thanked Dr. Marotta and Mrs. Sapienza Donais for their tributes for Gina Allen and Sheila Jameson and offered personal remembrances of both staff members. He noted the recent drop in COVID numbers in Haverhill. Mr. Davis referenced Governor Baker's decision-making in reversing the mask mandate. He also spoke about the spike in cases after the winter break and the number of schools that were on the verge of closing due to COVID. Mr. Davis asked for the mask mandate to be extended for two weeks to ensure that there is not another spike in illness after February break.

Mr. Timothy Briggs, 30 Hoyt Road, Haverhill, MA was speaking as a parent and teacher not as the HEA President. Mr. Briggs referenced the state decision and requested that a plan be developed to ensure a meaningful education in the district.

Mr. Jack Roy, Brandy Brow Road, Haverhill, MA advocated for parental choice in regards to masks.

Ms. Barbara Greenwood, outlined the negative impacts of mask wearing for children i.e., empathy. She supported parental rights.

Superintendent Comments/Reports.

COVID Update.

Superintendent Marotta announced the availability of free test kits.

Ms. Vozeolas reported on the COVID statistics and the steady decline in cases since mid-January.

Dr. Maddox commented that it was a difficult decision regarding masks. He stated that the district had navigated the pandemic in a thoughtful manner. Dr. Maddox was present to assist the committee in its decision-making. He referenced the 51% vaccination rate in the state and 32% in Haverhill in ages 5-11 (985 more students to reach the state level). Dr. Maddox reported that Massachusetts was in the red, highest level. He continued by citing several studies noting the decrease in transmission in schools with mask requirements.

Mrs. Ryan-Ciardiello asked for Dr. Maddox's opinion.

Dr. Maddox responded that mask removal was not a terrible idea.

Mayor Fiorentini asked about positivity rate in the city and the schools and which was a relevant rate.

Dr. Maddox noted that the community rate is a determining factor.

Attorney Magliocchetti thanked both Dr. Maddox and Ms. Vozeolas on their work. He asked what criteria Governor Baker used in his decision-making.

Dr. Maddox responded it was grounded on the vaccination rate in the state.

Ms. Vozeolas did not recollect a decision to use KN95 or N95 masks.

Attorney Magliocchetti noted the confusing amount of information.

Dr. Maddox referenced the negative mental health implications of mask wearing by children.

A motion was made by Mrs. Sapienza Donais to remove requirement effective February 28, 2022. Mrs. Ryan-Ciardiello seconded the motion.

Attorney Rosa tried our best to navigate through the pandemic. He noted that schools had been in session for a longer time than other districts. Attorney Rosa commented that pool testing had begun prior to any other communities. He emphasized the uncharted territory as a result of pandemic. Attorney Rosa suggested accommodations for medically fragile staff members.

Ms. Sullivan commended Dr. Maddox and Ms. Vozeolas for their efforts and willingness to advise the School Committee during these difficult times. She advised being proactive as a school committee and ensuring the test kits distribution.

Mr. Wood recognized the commitment of parents regarding this issue. He had supported mask mandates in the past and would now recommend the lifting of the mandate. Mr. Wood advised sensitivity to students and staff who wished to wear masks.

Attorney Magliocchetti inquired if the vaccination rates would increase with the lifting of the mask mandate.

In regards to the mayor's question on timing, Dr. Maddox noted it was not a perfect stage for mitigation.

Mayor Fiorentini was proud of the community's efforts during the pandemic. He was concerned about the 10% positivity rate and the timing and would not support the motion.

A motion was made by Mrs. Sapienza Donais to follow Governor Baker's recommendation and remove the mask mandate effective February 28, 2022. Mrs. Ryan-Ciardiello seconded the motion. A roll call vote was requested:

With a network of safety resources, updated procedures, guidance from our Medical Director, and up-to-date information on entry requirements and local restrictions throughout the world, we have been working tirelessly to make sure your experience this summer is successful and educationally rewarding.

There's no doubt that travel looks a little different these days. We have been monitoring policies at home and abroad for months, knowing that decisions for summer programs need to be made months in advance in order to give our Operations team the time to arrange the high-quality and immersive experiences we and our customers expect. What we have observed is not only relaxed border openings for fully vaccinated* foreign travelers, but also growing vaccine mandates across the world to participate in everyday activities, like indoor dining at restaurants and visiting cultural venues such as museums and theaters. As we look ahead, we must rely on the policies and restrictions of countries as they are today to start reserving your tour.

It is with this context in mind that we would like to share:

- At Explorica, Tour Directors and Course Leaders leading programs will be fully vaccinated.
- Explorica will support programs for fully vaccinated travelers to countries with a U.S. Department of State (DOS) Level 4 Travel Advisory when the sole reason for the heightened advisory is COVID-19, and where, based on an independent review, we have determined that the risks can be effectively mitigated by COVID-19 vaccination and other protocols.
- Explorica can plan for and support programs for travelers who are fully vaccinated to almost every Explorica destination through August 2022
- Based on entry requirements, local vaccine mandates, and DOS Travel Advisories, we feel confident supporting travel through August 2022 as follows:
 - o Travel to Europe, Costa Rica, and most other popular destinations is available for fully vaccinated participants.
 - Note that we will support private tours with unvaccinated travelers that are under 12 years old to any destination that does not require vaccines for that age group and does not have a DOS Level 4 Travel Advisory. However, should entry requirements change,



groups that have chosen to travel will need to follow country regulations at the time of departure.

- Travel to Mexico is available for fully vaccinated consolidated groups, or private tours of 15 or more total travelers with a mix of vaccinated and unvaccinated participants. Please talk to your Account Manager for more details.
- Although COVID-19 booster shots are not currently required to travel or re-enter the U.S., some countries have enacted a timeframe for which vaccinations are valid, counting from the date of the last dose received. Groups should be aware that many destinations could have booster shot requirements in place by summer, and each traveler should confirm their COVID-19 vaccination status is up to date for their destination. Explorica will continue to communicate any changes to destination entry requirements, including what is accepted as proof of vaccination.

Please note that this policy is only in effect through August travel. We will continue to monitor entry requirements and local vaccine mandates for on-the-ground activities, releasing a new policy regularly. Should you choose, you can postpone into the future for no fees. We would like to stress that summer tours are four months away, allowing ample time for all travelers to become fully vaccinated against COVID-19 and become eligible for travel. If you are a private group traveling to a destination other than Mexico with unvaccinated travelers and would like to wait and see if the situation changes, you can do so. Please just note that we do not see signs that individual countries will rescind vaccine mandates for summer travel, and we cannot begin booking a trip until we have confirmation that a group is either currently fully vaccinated or is committed to becoming fully vaccinated ahead of their departure.

We welcome every group to make the decision that works best for their situation and truly hope you choose to travel this summer. We ask that if you do plan on traveling given the information above, you let us know by February 4th, 2022 or before for groups departing before June 1st, and by February 18th for groups departing after June 1st, as we need to start arranging your trip immediately. Once you commit to travel, standard cancelation fees will apply. Postponing for no fee remains an option, as does canceling under our COVID-19 refund policy outlined at https://www.explorica.com/travel-with-confidence.

* What does it mean to be fully vaccinated?

According to the CDC, in general, people are considered fully vaccinated:

- Two weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or
- Two weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine

If you don't meet these requirements prior to your departure date, you are NOT fully vaccinated. The definition of fully vaccinated may vary by country, and your Account Manager will make you aware if your program location has different vaccination policy requirements.



Explorica by WorldStrides Travel Requirements through August 30th, 2022

The safety and security of our participants is, and always will be, our highest priority. To support travel in this new environment, Explorica by WorldStrides has been reviewing every aspect of our programs from pre-departure all the way to a program's return home to help mitigate the risks associated with COVID-19.

Our Health & Safety team continues to closely monitor the situation and will adjust our protocols as needed. All newly developed protocols are guided by current recommendations from the CDC and our Medical Director, Dr. Neal Sikka. As your program approaches, you will receive additional information related to your program and will be informed of any changes.

As we review travel plans and itinerary, please review the below travel requirements for your program.

Travel Requirements

- COVID-19 Vaccination Due to current policies and restrictions of countries as they are today, all participants must be fully vaccinated* at least 14 days before trip departure and carry their original CDC white card at all times. It is recommended to also have a digital photo of the front and back of your vaccination card available. The definition of fully vaccinated may vary by country and Explorica by WorldStrides will inform us if our program location has different requirements to comply with vaccination policies.
 - Although COVID-19 booster shots are not currently required to travel or re-enter the U.S, Explorica by WorldStrides strongly recommends that all program participants get their booster shot before travel if eligible. Participants should be aware that some destinations may have booster shot requirements in place by spring, and each participant should confirm their COVID-19 vaccination status is up to date for their destination. WorldStrides will continue to communicate any changes to destination entry requirements, including what is accepted as proof of vaccination.
- Pre-departure Testing Participants must schedule a COVID-19 PCR test taken within 72 hours or an antigen test
 taken within 48 hours of trip departure and submit test results to the Program Leader. The test must be a lab-based test
 at a testing facility or administered by a medical provider or pharmacy.
 - Testing requirements may vary based on destination.
 - Anyone receiving a positive test result will not be able to participate on the program. In this circumstance, they
 should not take a second test, since only the first result will be accepted.
- Re-entry Testing The Centers for Disease Control and Prevention (CDC) requires all air passengers to provide proof
 of a negative COVID-19 test result arriving in the U.S. This test will be arranged by Explorica by WorldStrides.
- Additional destination requirements If there are additional destination requirements, Explorica by WorldStrides will
 provide specific guidance based on program destination(s) in the coming weeks.
- Testing exception for participants who have recovered If a participant has been diagnosed with and recovered from COVID-19 within 90 days of departure, they may provide documentation of recovery (proof of their positive test and a letter from a healthcare provider or a public health official stating that they are cleared to travel) in lieu of a negative test result to meet the Explorica by WorldStrides pre-departure testing requirement. At least 10 days must have passed since the positive test and the date of departure to participate on the program. This is in line with CDC guidance that individuals should avoid travel until a full 10 days after their symptoms started or the date of their positive test if they had no symptoms.
- Close contacts If a participant has been in close contact with someone who tested positive for COVID-19 within 10 days of the program start date, they will not be able to participate in the program and should stay home.



Program Protocols Pre-departure

• **Limit exposure to others** – Participants are asked to limit time outside their home for 14 days prior to travel, with the exception of going to school or work or engaging in other essential activities. Please strictly observe COVID-19 safety protocols (masking, social distancing, and hand washing) and avoid large gatherings and crowded spaces.

On-program

- Chaperone support All Chaperones must adhere to the Explorica by WorldStrides Chaperone Expectations which includes modeling and enforcing program safety procedures.
- Daily symptom checks Participants will be asked several questions about how they are feeling to monitor for COVID-19 symptoms.
- Mask requirement Masks will be required throughout the duration of the trip in all indoor spaces and on the
 motorcoach, regardless of vaccination status. Participants may remove their masks when engaging in outdoor
 activities where social distancing from others not with the group can be maintained, provided that it meets country, local,
 or venue requirements. For maximum protection, the CDC is now recommending the use of either a KN95 mask (or
 equivalent such as FFP2 or KF94) or double mask, preferably a disposable surgical mask with a cloth mask. Some
 international destinations have specific mask requirements.
- Illness on-program If a participant exhibits symptoms of COVID-19, Explorica by WorldStrides will help them get tested and safely separate from the rest of the group while awaiting the results. The Program Leader will be in close contact with the participant as we work together to make arrangements for the participant's care plan. Explorica by WorldStrides will make every effort to secure quarantine/isolation accommodations in the same location as the group, although this may not always be possible. The participant's testing and medical expenses should be covered by insurance. As a reminder, Explorica by WorldStrides recommends that all participants bring a copy of their insurance card and use their insurance as primary where applicable. Explorica by WorldStrides will cover up to \$2000 per participant for lodging and meal expenses incurred during the quarantine/isolation period for fully vaccinated participants and children who are not eligible to receive a vaccine.
- Contact Tracing, Testing and Quarantine In the event a participant experiences symptoms of COVID-19, Explorica by WorldStrides working with their Doctors on Call or local health officials will provide guidance to the group to reduce the risk of additional exposure. Everyone's cooperation will be appreciated under these circumstances. The Program Leader will work with Explorica by WorldStrides to identify the roommates of the participant experiencing symptoms and any others within the group who may have been in close contact with the participant. Those identified may be required to quarantine, take a COVID-19 test, or in some cases do both, even if they are not experiencing any symptoms. Explorica by WorldStrides will help coordinate quarantine and testing of any additional participants as needed, and the Program Leader will be in close contact with the parent/guardian of the participant is impacted.

- 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or




