Public Comment (In-person & Remote).

Ms. Alicia Smolar, Edwin Street, Haverhill, MA spoke in solidarity for the educational support personnel.

Mrs. Trish Shaw, 114 Chestnut Street, Haverhill, MA provided data on Gateway ESP salaries with the lowest step amounts. She noted that the employees were not making a living wage.

Mrs. Ryan-Ciardiello assumed chairing the meeting at 7:08 pm.

Ms. Stephanie Gillen, 9 Cogswell Avenue, Bradford MA, Bradford Elementary ESP spoke in support of a living wage.

Mr. Barry Davis, HEA President disagreed with the assumption regrading living wage definitions and that there was not enough money in the budget to fund the wages. He related that the attorney fees doubled and reported that the school committee's law firm had been fired by Belmont Public Schools for its anti-teacher sentiments. Mr. Davis commented on the "threats" to go to mediation at the last bargaining session. He related that the citizens of Haverhill should know that the school committee hired an anti-school and anti-labor attorney with taxpayer funds.

Student Advisory Council Report ~ Melanie Palacios. Ms. Palacios was not in attendance.

Superintendent Comments/Reports.

Dr. Marotta reported that 2,000 students in summer school enrichment with a program that included STEM academics in the morning followed by camp attendance in the afternoon. Additionally, she noted that the Freight Farm project was providing the learning experience of growing lettuce, there were hands-on activities and afternoon enrichment. The superintendent outlined the several school moves/relocations occurring in the district: Tilton Upper Grade 4 to Consentino Middle for Grade 5; Tilton Lower Grade 3 stays at Tilton Lower for Grade 4; Silver Hill Grade 4 moves to Consentino Middle for Grade 5; Walnut Square Grade 2 stays at Walnut Square for Grade 3; Gateway Academy moves to St. James (Tilton Upper); and Moody School on Main (Preschool Extension) moves to Crowell School (formerly Gateway Academy). Dr. Marotta related that at Moody on the River a new handicap-accessible playground funded by the special education grant would be completed by late August.
