TENTATIVE MEMORANDUM OF AGREEMENT

SC 10.27.22 2 A

BY AND BETWEEN

HAVERHILL SCHOOL COMMITTEE

AND

HAVERHILL EDUCATION ASSOCIATION

Subject to Ratification and Approval.

1. Compensation:

FY23 4% COLA (retroactive to July 1, 2022), Remove Step 11 Roadblock, Blackout Step 4 (upon ratification)

FY24 3% COLA

FY25 3% COLA, THEN add \$1,000 to Step 14

2. Side Letter:

The Committee and the Haverhill Education Association mutually agree to establish an ongoing Safe Learning and Working Environment Taskforce to support a safe working environment. Nothing in this Side Letter shall be construed to limit or waive the District's inherent or customary managerial rights or prerogatives including those that may be referenced herein. The parties agree that only compliance with the processes outlined in this side letter shall be subject to the grievance and arbitration procedure. The outcome and work product of Section C and E below shall not be subject to the grievance and arbitration procedure.

- A. The Taskforce will be comprised of up to 4 appointees from the District and up to 4 appointees from the Haverhill Education Association
- B. The Taskforce will meet quarterly for the 22-23 school year.
- C. The Taskforce will review and develop mutually agreed upon district-wide, staff reporting forms and protocols regarding classroom safety issues. Items for the taskforce to discuss include but are not limited to:
 - a) A system that is electronic and accessible by all to members, that is clear and consistent and includes a mechanism for tracking, providing feedback to and follow up from administration and teachers.
- D. The Taskforce will first meet no later than one month following ratification of the CBA agreement with an established protocol and system established within 1 year from ratification. In subsequent years of

this agreement (SY 22-25), the first meeting will occur no later than September 15th to determine any changes to the processes developed. In subsequent years of this agreement (SY 22-25), the Taskforce will meet bi-annually or by mutual agreement, but not more than quarterly.

- E. The District will continue to provide training to existing and future personnel on the mutually agreed upon system and protocol, and will continue to make ongoing training and reasonable resources available to all staff.
- 3. To be added to the Preamble:

In acknowledgement of the harms and inequities caused by societal systemic racism, the District and Association agree that anti-racist policies and practices are a priority, and agree to collaborate on anti-racist action. The School Committee and HEA recognize that since 2018 the HPS has made great efforts to educate and diversify to be more inclusive and reflective of our student body. Thus far this effort has been led by the school administration and has included but not been limited to Curriculum Bias Initiatives, Diversity Recruitment/ Retention Committees, Lynch Leadership Micro Academy, Equity Imperative, and DESE Culturally Responsive Teaching and Leading Academies. The district welcomes the support of the HEA in the leadership and expansion of this work.

- 4. The HPS is cognizant of the rules and regulations of Special Education classroom size and compliance measure of 603 CMR 28.06 (6) c,d,and e.
- 5. To be added to Article IV- Mutual Concerns:

The Committee and the Association mutually agree to work in the established Mutual Concerns monthly meeting to address the following:

- Reasonable and equitable duties, workloads, and resources among departments and schools.
 - In recognition of the school committee and HEA's joint desire for equity in workloads, resources and responsibilities across the school system, topics of discussion may include:
 - Planning time, curriculum meetings, district directed meetings and teacher discretion.
- Diversity, Equity, and Inclusion:
 - This will include but not be limited to the continued inclusion of Association members in all anti-racism, inclusion, diversity, and equity training and the exploration of ways to hire, support, and retain individuals from underrepresented populations.
 - The School District will continue to work with the Association to develop plans to recruit, employ, and retain individuals from underrepresented populations. The Parties agree to continue this work throughout the 22/23 school year.

The HEA shall propose an agenda seven school days in advance that shall identify the topic to be discussed, and administration may propose additional topics for discussion. The JLMC shall continue to meet by mutual agreement.

Return to Work Agreement:

The Haverhill School Committee will permit all members of bargaining units represented by the Haverhill Education Association (HEA) to return to their regular duties without disciplinary action for engaging in a work stoppage on October 17 through 20.

The HEA shall not take any reprisals against any members of the bargaining units represented by the HEA who worked during the work stoppage or take any retaliatory action against any students, parents or employees.

The Committee will schedule, and the HEA agrees that its members will work, the one hundred eighty (180) days of instruction for students in the 2022-2023 school year, and the members of bargaining units represented by the HEA shall be paid their regular negotiated compensation for all days worked and will have no loss, reduction, or interruption of pay based on the work stoppage.

The HEA will inform the Superior Court on October 21, 2022 that: (1) the parties participated in a mediation session on October 20, 2022; (2) the parties reached a tentative agreement 9:35 p.m. on October 20, 2022, and there is a ratification vote scheduled for a date on or before October 21, 2022; (3) the teachers will return to work and the Haverhill Public Schools are open on October 21, 2022.

The HEA hereby agrees to pay the Committee \$200,000 that will cover reimbursement of expenses and/or damages that the Committee incurred from October 17, 2022 until the teachers return to work on October 21, 2022 including but not limited to legal fees associated with preparation for and representation at the DLR/CERB pre-hearing conference and hearing and preparation for and hearings in Superior Court, police details/overtime, child care, labor to prepare and distribute meals for students and the ingredients for meals for students on October 17, October 18, October 19, and October 20, 2022. Such payment to be made to the Haverhill Public Schools and delivered on or before June 1, 2023.

The HEA hereby agrees to pay the Committee \$50,000 for the purposes of launching a Future Hillie Educator scholarship fund for HPS graduates of under-represented minority populations, who upon graduation from high school, attend a Massachusetts Public College or University to pursue training to become an educator. The scholarship recipients will be jointly chosen by HPS and HEA.

Dear School Committee,

Per the request of Attorney Magliocchetti, Facilities Director Steve Dorrance conducted a cost analysis for adding parking spaces at the Haverhill High School. Mr. Dorrance and the City Engineers identified 3 potential areas to be utilized for additional parking. Of the 3 areas, only one seemed viable – the area behind the Library wing. That area would yield between 42 and 54 additional parking spaces.

Mr. Dorrance does not recommend the use of gravel as it is not plowable, does not pack down and causes other potential issues. He has recommended using either Multipack (recycled paving material) or asphalt.

The cost estimates are as follows:

Multipack \$67,100 Asphalt \$138,050

Attached are backup documents and a sketch of the area.

At this time, I am concerned about funding this unbudgeted project. I would recommend sending this to the Finance Subcommittee for further consideration and recommendations.

Mike,

Last Thursday, I met with representatives of the City including fire, code enforcement, engineering, and others to discuss three potential parking areas:

Area A. next to the tennis court, yield approximately 16 spaces.

Area B. behind the gym, contiguous to the existing C lot, yield approximately 16 spaces

Area C. behind the library, yield between 42 and 54 spaces. There could be a potential net loss of 8 spaces, depending on the final layout.

For a variety of reasons, the team felt areas A and B were less desirable than area C. Area A would require cars to, potentially, back out into traffic, and is sloped upwards from the street to the courts. Area B was felt to be tight and would need infill because of the uneven grade and slope on the edge of D lot. Area C would by far yield the most spaces, is flat land, and has room to pile snow around the edge. Area C is bounded by the tree line. A few feet into the tree line, a distance which varies along the line, there is a significant elevation change, therefore, cutting into the tree line would be expensive.

For visualization purposes lot E would continue in its current design all the way across Area C to the tree line. The size of parking spaces is regulated by code so, we just can't squeeze more in. For planning purposes 9x20 is used to calculate the area of a parking space.

WE DO NOT HAVE AN ESTIMATE! In order to get a reliable estimate, engineering designs must be completed, a determination has to be made about the number of parking spaces, and a final determination about the location of the parking area has to be made. The contractor, who has done work for the school department, and recently did parking lot work at the police station is both reputable and reliable but at this stage, based on the known information, all he has been willing to provide is a magnitude of cost number. Area C does have a catch basin proximate to the parking area at the edge of the fire lane. Depending on topography, additional connections to the existing drain might have to occur.

Materials/Cost: There are two options for parking area, multipack and asphalt, gravel is not an option. Gravel is unsafe to walk on, does not firm up and continues to move with traffic use, and easily plows up. Multipack is reprocessed asphalt that has been removed from streets. A large aggregate gravel base is put down first and then several inches of the reprocessed base asphalt is added and compacted with a vibratory compactor. We used multipack to add parking on the left side of JG Whittier. Multipack can be plowed up if the contractor isn't careful, however, the surface is firm. I discourage using multipack "now" and then adding asphalt to it next fiscal year because it will all have to be regraded, and some material will have to be removed in order to accommodate the 2 inches of finished asphalt. Asphalt is a "permanent" solution and by far the best value over time.

Timing: None of the City officials, or me, believes we can get this work done before first snow; design drawings have to be done, a bid package has to be prepared, contractors evaluated, and a permit pulled. This assumes there are sufficient resources available to fund the project. The City will not grant a permit without plans.

Contracted Work: The District does not have any of the necessary skills or equipment to do this work. Equipment that we don't have includes a gradall, vibratory loader, backhoe, large loader, dump truck of any kind, lasers and other equipment to shoot grades, etc. Additionally, there is no pipe laying expertise in the department. Lastly, we do not have any onsite area to put excavation spoils. At least 4 inches of soil, perhaps 6 will have to be removed from the majority of area C.





Haverhill Public Schools - School Committee Hybrid Regular Meeting Minutes of October 13, 2022

Roll Call - Pledge of Allegiance.

Mayor James Fiorentini, Chair called the meeting to order at 7:00 pm and requested a roll call of the members:

Dr. Margaret Marotta, Superintendent of Schools and Mr. Michael Pfifferling, Assistant Superintendent of Schools were also in attendance at the meeting.

Mayor Fiorentini read an act relative to extending certain COVID-19 measures adopted during the state of emergency was signed by Lt. Governor Polito and allows for remote meetings and hearings by public bodies through March, 2023. This meeting will be available via live streaming over HCTV and WHAV. The full meeting recording will be posted on the HCTV website.

The Pledge of Allegiance was led by the members of the JROTC and recited by the audience.

Mayor Fiorentini requested a moment of silence be observed in memory of the late Judge Kevin Herlihy.

Mayor Fiorentini left the council chambers due to the nature of public comment regarding teacher negotiations, which he was not to have any involvement. Mrs. Sapienza Donais, Vice Chair assumed chairing the meeting.

Communications/Reports.

Public Comment (In-person & Remote) – see policy summary on the next page.

Mr. Marc Harvey, 8 Byron Street, Haverhill, MA, a HPS teacher, parent, and taxpayer stated his vested interest in the public schools. He commented on the statement released by the public relations firm Ellis Strategies hired by the district, that misled the public and demonize the HEA. He noted that the pamphlet contained propaganda about current salaries and retention rates. Mr. Harvey asked who authorized payment and referenced that this firm was hired with taxpayer dollars.

Ms. Sheeba Nabiryo, 206 Boxford Road, Haverhill, MA, a high school student spoke in support of her teachers and the September 20, 2022, walk-out by high school students. She reported that the activity was totally independent of the teachers' association. Ms. Nabiryo acknowledged that the students did deserve a detention for the protest and continued with lack of urgence and respect during collective bargaining sessions. She highlighted that the wages were \$10,000 below the state average. Sheeba was 100% supportive of our teachers.

Attorney Magliocchetti acknowledged the student's comments and indicated students would always be heard by the committee.

The mayor returned at 7:13 pm and resumed chairing the meeting.

Student Advisory Council Report ~ Sean Wynn.

Sean provided an update to the committee:

- Leah Colantoni passed Certified Nurse Aide as part of the Health Care/CTE Program;
- Discussions with administration regarding the iReady dissatisfaction; cleanliness of bathroom and pool area; and changes to sex education curriculum;
- Student concerns with tensions over the teachers' contract and hoped for a speedy conclusion.

Superintendent Comments/Reports.

Superintendent Marotta acknowledged that the everyone agreed that there were fabulous and outstanding students in the Haverhill Public Schools.

The superintendent recognized the tremendous contributions of the JROTC program and wanted to acknowledge their contributions and accomplishments. She requested that 1st Sgt. David Grinstead and Gunny Sergeant Henry Danis address the committee.

1st Sgt. Grinstead indicated he was a retired marine (36 years of service) who lived in Salem, MA. He reported the following accomplishments/activities:

- 5,000 hours of community service;
- 13 students graduated and some have graduated boot camp; 3 marines and 1 soldier and several awaiting entrance to Army;
- \$484,000 scholarship monies awarded to seniors;
- Thriving program (Naval Honor School = top 20% of ROTC in the nation);
- Haverhill High School MCJROTC hosted a Raider Competition on October 8, 2022 and dominated! Our Alpha team won 1st place overall and our Bravo team won 4th place overall out of 12 teams competing and additionally, put 10 more trophies on the table.
- Regular competition schedule and noted that there would be a request for December to compete in Reading, PA.

1st Sgt. Grinstead acknowledged Gunny Sgt. Danis, three (3) senior cadets along with the executive officer who is also the senior class president:

- Cadet Major/Commanding Officer Kali Sevene noted that there were 102 cadets plus 14 grade 8 cadets in program along with her duty to lead cadets to be successful after high school
- Jeremy Ortiz Ferreiras, Cadet/Sgt. Major whose duty was to be in charge of the enlisted staff. His goal was to be a marine, attend college and be commissioned as an officer;
- Cadet Captain/Executive Officer Deyanarah Gutierez offered testimony on her experience in the MCJROTC. Ms. Gutierez acknowledged that the program simply changed her life by bringing her outside of her comfort zone and instilling the drive to work harder in all aspects of life. She met people that will always stick by her and believed that the challenges, the people, the connections, and the family attributed to her personal growth and development.

1st Sgt. Grinstead noted that all participants did not need to enter the military, but the goal of the program was to prepare students for the future.

Attorney Magliocchetti expressed his appreciation for the program and thanked the students and staff. He noted that his friend a retired marine was watching from home (it was his birthday and it made his day). Attorney Magliocchetti was impressed with the students' accomplishments and the program.

1st Sqt. Grinstead announced that today was the Navy's birthday.

Mr. Wood was appreciative of the presentation and thanked the staff for the program's development and was an amazing program especially eighth grade mentoring and instilled skills that would assist all students. He asked that parents consider this program for their students in terms of a foundation for success in all endeavors.

Mrs. Sapienza Donais expressed "Hillie Pride" and noted the impressive number of awards received by the MCJROTC.

Mayor Fiorentini recognized students for their participation in the 9-11 memorial ceremony and wished them the best.

Dr. Marotta thanked the students and acknowledged their work in the community and the schools.

Superintendent Marotta referenced the MCAS Data Review MCAS 2022 PP Draft.pptx (1).pdf. She indicated a more detailed presentation would occur at a future meeting. The superintendent asked the committee to review the materials in the meantime.

School Committee Reports/Communications.

Attorney Magliocchetti: Safety Specialists Contract Update. Both Attorney Magliocchetti and Mrs. Sapienza Donais commented that the negotiations were close to conclusion and that a contract negotiations session had been scheduled for Wednesday, October 19, 2022. Mrs. Sapienza Donais concurred with this statement.

Attorney Magliocchetti: Parking Lot Expansion at HHS. Attorney Magliocchetti recognized the need for additional staff parking spaces and wondered if there was space at the back of the school that could be converted to parking prior to the winter season.

Superintendent Marotta would investigate the possibility of additional parking.

Attorney Rosa inquired about the reason for limited parking and suggested designated parking (white lines for staff and yellow lines for students).

Superintendent Marotta responded that students had assigned spots, but with additional staff there was limited parking.

Mr. Wood asked for the specific concerns i.e., staff parking or student parking.

Mrs. Sapienza Donais responded that additional high school staffing had impacted the already challenging parking this year.

Attorney Magliocchetti: Teachers' Negotiations Update.

Mayor Fiorentini read statement regarding having a conflict of interest (his son is a teacher), based on the advice of ethics commission which prohibited from involvement in teacher negotiations and was not allowed to vote on the contract.

The mayor left the meeting at 7:39 pm and Mrs. Sapienza Donais assumed chairing the meeting.

A statement was read by Mr. Wood, Chairperson of the Teachers' Negotiating Subcommittee which was endorsed by the full committee except the mayor. Mr. Wood, in his role as "chairperson of the teachers' negotiating subcommittee I want to make clear that the statement is from the full school committee by unanimous vote at the last school committee meeting Tuesday night before the negotiation sessions so I am reading it, but this is from every member.

Statement for the October 13th school committee meeting as you know the negotiations committee has been working on a new contract for our teachers since the end of May unfortunately, we have not been able to come to an agreement yet besides good faith efforts by our committee. It wasn't until last week the beginning of the fifth month of negotiations that the union presented us with a full contract proposal and a counter wage proposal; and like the first the salary demands are unaffordable and unrealistic. What they are seeking is beyond what the city and its taxpayers can afford; the HEA proposal would cost \$39 million and will increase property taxes for Haverhill homeowners over \$1350 over the next three years.

By comparison our counterproposal would give our teachers their highest cost of living increase in over 20 years, and would reward our most experienced educators with a further increase. Contrary to the union's rhetoric, the offer is not business as usual. It is the most generous offer in recent memory which emphasizes the value we place on our teachers in education. We know that our teachers have been subjected to extremely difficult teaching environments over the last few years because of the pandemic as well as other societal issues. It's important to know that we have invested a considerable amount of state and federal Covid relief money into the district, adding 80 new positions in the last two years including support staff, interventionists and school adjustment counselors to address the social emotional learning needs of our students in the work environment for our teachers.

The HEA is now talking about a possible strike not only is it against the law in Massachusetts for teachers to go on strike but also such an action would cause great harm for our students and the

families. We know the many educators do not want to walk off the job but they are facing unrelenting pressure from the union leaders to fall in line. Three is an article HEA members are sharing features this statement: why do you rob banks a reporter once asked Willie Sutton, because that's where the money is, the infamous thief replied – why go on strike because that's where our power is — it is obvious the union leadership has a larger social agenda beyond which is in the best interest of the people of the city of Haverhill and the financial interests of its members. We remain focused on the students and their families and we will continue pressing ahead to reach a settlement that is fair and equitable and that the city of Haverhill's people can afford. Thank you."

Attorney Magliocchetti stated the difficulties and the financial complications. He stated that the committee valued the teachers. Attorney Magliocchetti noted that the Initial proposal would have impacted the average taxpayer by \$1,500 and cost \$46M. He acknowledged the correction of some inadequacies in the last contract (with a huge benefit) and the correcting of some imbalances in the salary scale. Attorney Magliocchetti noted the need to settle the contract.

Attorney Rosa related that there had been movement in the number of steps in the last contract that there were inequities, however, the last contract did include tuition reimbursement and did provide corrections in many areas. He stated that step increases did come at a cost.
