Haverhill Opt-Out Procedure

Every district implementing or maintaining a curriculum that primarily involves human sexual education or human sexuality issues is required to adopt a policy ensuring parental/guardian notification. This policy must allow parents or guardians to exempt their children from any portion of the said curriculum through written notice to the school principal.

Haverhill Public Schools Health teachers- provide a uniform letter to students and families (email, newsletter, google classroom, etc.) prior to sex ed instruction/lessons for notification and the ability to opt-out. Students can be supervised in another location & provide alternative assignments. HHS has a video presentation available to families about what is offered for Health/PE and regarding sex education topics. A signature on the notification letter is only asked if the student opts out of the class(es).


HHS Student Council Survey 2021-2022


Student Concerns Last Year & Solutions This Year

Student Concern	Solution
Topics not covered in depth, need to be more thorough	Changed curriculum mapping
Limited discussion of LGBTQ and identity	Increased sex education to include 4-5 more classes, added LGBTQ anti-bullying lesson to curriclum, workshops in Health I & II on healthy/unhealthy relationships w/ YWCA
Sex ed unit skipped	Skipped for one class due to lack of consistent teacher
Not enough time	Based on Health I end of semester survey 2022-2023, all topics covered
Repetitive lessons	Survey data show most students learned more than they thought in all topics and all students reported making positive changes
No google classrooms	Google classrooms provided for all classes with materials posted


