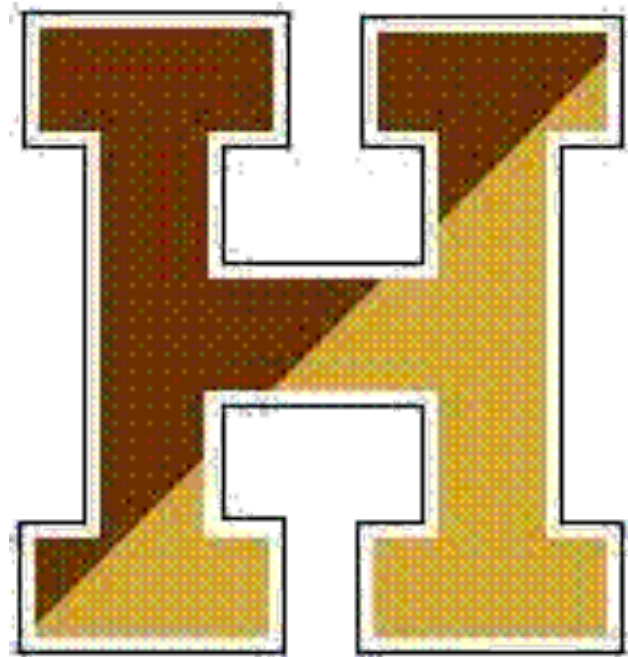

The Haverhill School Committee aims to provide a straightforward and transparent process for Whittier Tech School Committee appointments.

1. Eligibility: Whittier Tech School Committee applicants must reside in the City of Haverhill. All applicants shall submit to a background check pursuant to policy [ADDA](#).

2. Application Process: The Haverhill School Committee will announce an application period and selection date before the expiration of a Whittier Tech School Committee member's term or as a result of a vacancy.

i. Applicants must submit a letter of interest to the Haverhill School Committee Chair, with a copy to the Haverhill School Committee Vice Chair, outlining their motivation for serving and vision for Whittier Tech. Applicants may provide a resume and up to three letters of recommendation.

ii. Applicants shall address the Haverhill School Committee for up to a prescribed time at a School Committee meeting on the selection date.

iii. Haverhill School Committee members who wish to serve on the Whittier Tech School Committee do not have to provide a letter of interest but should inform the Chair and Vice Chair of their interest in writing during the application period.

iv. If the Haverhill School Committee receives more than five applications, the Haverhill School Committee Policy Subcommittee shall meet to review applications and narrow the number of candidates for the Haverhill School Committee to consider to five.

v. The Haverhill School Committee will strive to make the application period at least two weeks, starting at least three weeks before the selection date.

Massachusetts School Immunization Requirements

Grades Kindergarten–6

DTaP/Tdap	5 doses; 4 doses are acceptable if the fourth dose is given on or after the 4 th birthday; DT is only acceptable with a letter stating a medical contraindication to DTaP
Polio	4 doses; fourth dose must be given on or after the 4 th birthday and ≥ 6 months after the previous dose or a fifth dose is required; 3 doses are acceptable if the third dose is given on or after the 4 th birthday and ≥ 6 months after the previous dose
Hepatitis B	3 doses; laboratory evidence of immunity acceptable
MMR	2 doses; first dose must be given on or after the 1 st birthday, and second dose must be given ≥ 28 days after first dose; laboratory evidence of immunity acceptable
Varicella	2 doses; first dose must be given on or after the 1 st birthday and second dose must be given ≥ 28 days after first dose; a reliable history of chickenpox* or laboratory evidence of immunity acceptable

Tdap	1 dose; and history of DTaP primary series or age-appropriate catch-up vaccination; Tdap given at ≥ 7 years may be counted, but a dose at age 11–12 is recommended if Tdap was given earlier as part of a catch-up schedule; Td or Tdap should be given if it has been ≥ 10 years since last Tdap
Polio	4 doses; fourth dose must be given on or after the 4 th birthday and ≥ 6 months after the previous dose or a fifth dose is required; 3 doses are acceptable if the third dose is given on or after the 4 th birthday and ≥ 6 months after the previous dose
Hepatitis B	3 doses; laboratory evidence of immunity acceptable; 2 doses of Heplisav-B given on or after 18 years of age are acceptable
MMR	2 doses; first dose must be given on or after the 1 st birthday, and second dose must be given ≥ 28 days after first dose; laboratory evidence of immunity acceptable
Varicella	2 doses; first dose must be given on or after the 1 st birthday and second dose must be given ≥ 28 days after first dose; a reliable history of chickenpox* or laboratory evidence of immunity acceptable
Meningococcal Grade 7–10	1 dose; this dose must be given on or after the 10 th birthday. Meningococcal conjugate vaccine, MenACWY (formerly MCV4) and MenABCWY, fulfill this requirement; monovalent meningococcal B (MenB) vaccine is not required and does not meet this requirement
Meningococcal Grade 11–12 †	2 doses; second dose MenACWY (formerly MCV4) must be given on or after the 16 th birthday and ≥ 8 weeks after the previous dose; 1 dose is acceptable if it was given on or after the 16 th birthday. Meningococcal conjugate vaccine, MenACWY (MCV4) and MenABCWY, fulfill this requirement; monovalent meningococcal B (MenB) vaccine is not required and does not meet this requirement

CONSIDERATIONS

- Medical exemptions (statement from a physician stating that a vaccine is medically contraindicated for a student) must be renewed annually at the start of the school year - **HPS has 1 student with a Medical Exemption**
- Religious exemptions (statement from a student or parent/guardian, if the student is <18 years of age, stating that a vaccine is against sincerely held religious beliefs), should be renewed annually at the start of the school year - **HPS has 109 students with Religious Exemptions**
- A reliable history of chickenpox includes a diagnosis of chickenpox or interpretation of parent/guardian description of chickenpox by a physician, nurse practitioner, physician assistant, or designee

What happens when a student (or staff) is diagnosed with Chickenpox?

- School Nurse communicates with Haverhill DPH
- Students and staff with varicella should be excluded from the school setting and should self-isolate at home unless medical care is needed until all lesions have crusted or, in vaccinated patients who do not develop vesicles, until no new lesions occur within a 24h period (typically 4–7 days).
- Letter sent home to families of students in the classroom
- School Nurse reviews medical records of students in the same classroom for vaccination status
- Contacts who are unvaccinated and without other evidence of immunity should be excluded from the outbreak settings from day 8 to 21 after exposure. Once these contacts are vaccinated, they can return to the school.
- Similar processes would be followed for other vaccine preventable infectious illnesses with exclusion based on incubation and contagion periods of the specific illness

HPS Illness Exclusion Guidelines



Staying Home When Sick

If a child's needs while sick with an infectious illness would interfere with the school staff's ability to teach and care for other students, the child should stay home. Schools must balance the risk of infectious disease spread with educational, social and mental health needs of children when determining when students should stay home.

If someone has the following symptoms, they should stay home (or be dismissed):

- Fever, including a fever with a new rash
- Vomiting more than twice in the preceding 24 hours
- Diarrhea that causes 'accidents,' is bloody, or results in greater than 2 bowel movements above what the child normally experiences in a 24-hour period
- Skin sores that are draining on an uncovered part of the body and are unable to be covered with a bandage
- Respiratory virus symptoms that are worsening or not improving and not better explained by another cause, such as seasonal allergies

**The CDC definition of fever: temperature 100.4 or greater, or feels warm to the touch or gives a history of feeling feverish*

Return to School criteria

- No fever (and is not using fever-reducing medicine) for at least 24 hours
- Fever with a new rash has been evaluated by a healthcare provider and fever has resolved
- Uncovered skin sores are crusting, and the child is under treatment from a provider
- Vomiting has resolved overnight and the person can hold down food/liquids in the morning
- Diarrhea has improved; the person is no longer having accidents or is having bowel movements no more than 2 above normal per 24-hours period. Bloody diarrhea should be evaluated by a healthcare provider prior to return
- Respiratory virus symptoms are getting better overall for at least 24 hours. Students and staff returning after a respiratory illness can consider additional actions to reduce spread

Guiding principles:

1. Our primary goal is to maximize school attendance and its benefits for all students, while also minimizing the spread of infectious diseases
2. School nurse assessment is guided by Standards of Practice
3. Haverhill Public Schools aligns with CDC and MA DPH/DESE guidance, including prevention strategies (such as immunization, hygiene and ventilation)
4. There may be instances when these procedures are adjusted due to community disease spread (e.g. an outbreak or pandemic or time of excessive absences)
5. School staff who are assigned responsibility for caring for sick children or who will be exposed to infectious materials have access to personal protective equipment

What did we learn from COVID?

1. Kids need to be in school
1. We, the educators and school health professionals, need to take care of ourselves physically, mentally, emotionally and socially in order to educate and care for these kids

i. The Haverhill School Committee will give preference to Haverhill School Committee members for one of the two positions, but appointing a member is not required. If a Haverhill School Committee member is appointed to the Whittier Tech School Committee and chooses not to run for reelection or is not reelected before the end of their three-year term the position shall be considered vacated, and the appointee must reapply to the Haverhill School Committee if they want to finish their term on the Whittier Tech School Committee.

ii. Appointments to the Whittier Tech School Committee are at the sole discretion of the Haverhill School Committee.

iii. The Haverhill School Committee shall make appointments at a public meeting.

4. Reporting and Responsibility: Whittier Tech School Committee members shall periodically report to the Haverhill School Committee as set forth below and have the following responsibilities.

i. Appointees will attend a minimum of seventy-five percent (75%) of Whittier Tech School School Committee meetings.

ii. Appointees will report to the Haverhill School Committee on Whittier Tech's progress, challenges, and matters requested by the Chair or Vice Chair.

iii. Appointees will report to the Haverhill School Committee at its first meetings in October, February, and May, and as requested by the majority of a quorum of the Haverhill School Committee.

5. Term of Appointment: Appointments to the Whittier Tech School Committee will be for three-year terms.

i. Appointees may apply to be reappointed during the application process before the end of their term.

ii. The Haverhill School Committee shall fill its Whittier Tech School Committee positions as vacancies occur using the same application process outlined above.

iii. The Haverhill School Committee may remove any appointee from the Whittier Tech School Committee by a majority vote of a quorum present at a public meeting for violation of this Policy or other cause following notice and a hearing.

Public Comment.

Mr. Barry Davis, 351 Center Street, Dorchester, MA, Haverhill Education Association President, who represents ESP's, teachers, clerical workers and security requested the school committee give consideration of one negotiating team for all four employee groups. He stated that the request was based on respect for the schedules of all the parties. Mr. Davis was open to discussion of various formats in order to resolve the contracts in a timely manner.

Stephanie (a parent), Blaisdell Street, Haverhill, MA informed the members that her children had been denied special education services, which was a legal requirement. She referenced her children and their needs, along with its emotional impact on the family. Stephanie referenced improper vetting of educational support personnel in the district, and stated that was speaking for all parents. She urged the school committee to address the denial of special education services along with overcrowding issues in the schools. Stephanie requested that these matters be addressed as soon as possible.

Mrs. Sapienza Donais asked the parent to leave her contact information so that someone would be able to reach out to her to address her concerns.

Mayor Barrett noted that the school committee did not usually comment during public comment, but she would allow responses at this time.

Ms. Rivera thanked the parent for advocating for her children.

Student Advisory Council – Ms. Molly Jordan.

Ms. Jordan reported that the second week of February would be Spirit Week, on Thursday, February 12, 2026, a survey will be sent out for Movie Night. She stated that there was an ongoing effort to get more diversity on the student council, noting that the GEMS Advisor had responded to their request for a meeting.

Teacher of the Year Charlie Matthews, Gateway Academy.

Mr. Downs provided Mr. Matthews background in coming to the Gateway Academy, namely, he was a former chef.

Mr. Matthews thanked the mayor and school committee along with the superintendent and principal for their support of the Farm to Table Program. He reviewed the presentation with the members.

Mayor Barrett commented that cooking/feeding your family was an important life skill. She asked about Serv Safe Certification for students.

Mr. Matthews responded that this certification was a goal of the school.

Mayor Barrett thanked Mr. Matthews and the staff at Gateway Academy.

Mrs. Basiliere remarked on the holistic approach along with integration of all disciplines in the students' studies. She remarked on her background as a former chef and currently a nurse. Mrs. Basiliere understood students' excitement in going to school at Gateway Academy.

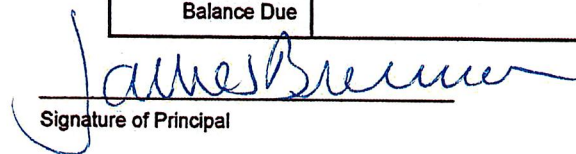
